### 2021 SOTH Annual Meeting 1/17 Minutes

Pr. Neu opened the meeting with prayer at 10:45. Attending were John and Joyce Sweeney, Steve and Emily Rappold, Donald and Tom Koch, Ruth Schwinge, Ron Gustafson, Ernie and Andrea Englehardt.

The minutes from the 2020 annual meeting were approved as presented.

Steve presented the treasurer's report and the proposed 2021 budget which was approved unanimously without change. Steve mentioned the strong financial situation of the congregation and that financially we can continue to meet our obligations for several more years regardless of local giving.

Pr. Neu presented his report and Ernie expressed the congregation's sincere appreciation for his dedication to SOTH during this past difficult year.

Donald suggested and Ernie agreed that the chairman's report be edited to change the wording "virtual communion" to "at-home communion."

The slate of officers was presented. Ron moved the state be voted in as presented and Donald seconded the motion. It passed unanimously. Serving for 2021 will be Ernie Englehardt, Chair, Steve Rappold Treasurer and Building Committee Chair, Tom Koch, Worship Committee Chair, John Sweeney, Financial Secretary, Ron Gustafson, Member at Large, Andrea Englehardt, Secretary.

### **New Business**

Donald expressed appreciation for how Zoom has enabled our worship experience to continue and allowed him to attend even when he was out of state. He suggested that even after in-person worship has resumed, SOTH consider somehow continuing with Zoom so that he might still attend when out of state and also others unable to be in Montpelier can benefit from the worship services.

Donald also expressed a hope that Easter Sunday might mark the resumption of in-person worship. Others were also hopeful but all felt the decision can not be made today and it will depend on the vaccine and when all will be protected from Covid and members can safely gather without endangering themselves or others.

Donald suggested midweek Lenten services and Pr. Neu will research materials and make the final decision about materials and time. Wednesdays will probably be chosen.

John thanked Tom for arranging for the appraisal of the building which was \$300,000 to \$349,000, and wondered if the congregation needed to vote on anything to do with marketing the building at this meeting. Emily suggested that the decision wait until the summer. She suggested that in the summer the building be put on the market for the appraised amount to see if SOTH can sell it for that amount. Others mentioned that consideration needs to be made about the continuance of an in-worship experience and the complications that brings if the building is sold. Andrea mentioned that Websterville Baptist

is still very much interested in SOTH's building despite the fact that they can not purchase it at this time because they are already expanding into another church near their school.

Ron moved for adjournment at 11:10 and Steve seconded the motion. Pr Neu concluded the meeting with prayer.

Dear Members and Friends,

We continue to be blessed by the leadership of the Reverend Frederick (Rick) Neu in worship, Bible study, at council and congregational meetings and in most other facets of our ministry. #### **OUR WORSHIP LIFE, 2021**

Difficult as it may seem, perhaps we should look at the worship life at Shepherd of the Hills in 2021 as an opportunity for new experiences, rather than a problem. Certainly, the year was different as a result of the pandemic.

We began by continuing worship online while waiting for the newly approved vaccines to become widely available. In the course of this forced community-without-contact, we struggled with the theology of "in-home communion," eventually concluding that as the Church has adapted to changing situations through the ages, so it is appropriate to meet the challenges of the pandemic with technology never before available to the Church. So we began to experience Holy Communion while physically separated, each in one's own location, courtesy of ZOOM! In so doing, we tried to make clear that Holy Communion under these circumstances was not "virtual" but real, for if it were not real, we wouldn't be doing it this way in the first place.

Admittedly, worship via ZOOM has its obvious disadvantages, especially when we have glitches in the technology. On the other hand, online worship enabled several people to attend regularly who otherwise would have been too far away to join us: Pastor's relatives in New York, Florida, and Italy; Sicards in Danville; and Donald wherever he might "be truckin" on any given Sunday morning.

As we moved into summer, we were able to resume in-person worship, though with some restrictions: no hugs, kisses, or even handshakes during the Peace; the Sacrament offered through individual, pre-packaged, kits; sometimes trying to sing through masks; etc. But at the end of the year, the Omicron strain of the virus left us wondering how long we could continue to meet in person. [Update: As of this writing, we are back worshiping online until such time as we believe it is safe and responsible to gather once more as a congregation.]

As we moved into a new liturgical year, Pastor Neu also led us in four online mid-week devotions.

We appreciate more than words can express the faithfulness of our worship leaders: Pastor Rick Neu, Rev. David Vanderlinde-Abernathy; and Rev. Patricia Harris, who left midyear with her husband, John, to live permanently in Florida. Thanks, as well, to Lea Hatch and Matthew Nunnelley for leading us in music. And very special thanks to Laura Amell, who faithfully chooses our hymns and prepares and distributes our worship bulletin each week; she also leads with piano when her schedule allows (which we wish could be more often!), and she prepared special music and played at our Christmas Eve service. Laura, you are appreciated more than you know!

It is perhaps well to remember that the Church has dealt with challenges throughout the ages, and this pandemic probably rates as one of the lesser such challenges. Through it all, we are still "The Church," and we need to remember the words with which we are dismissed at the end of each Communion service: "Go in peace; serve the Lord!"
